1. Introduction

Neu Voice Solutions is committed to ensuring your privacy is protected. This privacy policy outlines how your information is collected, used, and safeguarded in compliance with the Data Protection Act 2018 and the UK General Data Protection Regulation (GDPR).

2. Information Collected

Depending on the service you access, Neu Voice Solutions may collect the following information:

- Name, date of Birth (DOB), contact information, including email address, postal address, telephone number, and next of kin
- Specific medical referral information and the names of relevant healthcare professionals involved in your care
- Medical insurance membership number and authorisation code
- Information about your preferred learning styles, experiences, and social information



- Ongoing progress notes during the period of service provision (e.g., speech therapy, training, or supervision)
- Information with prior consent from third parties e.g. other health care providers alternative and allied professionals, nurseries and schools

3. Use of Information

Your information is used to understand and meet your treatment needs. Specifically, it is used for the following purposes:

- Internal Record Keeping: To manage and document therapy and service delivery.
- **Communication:** To send therapy summaries, clinic letters, and other relevant information by post or email as agreed with you.
- Invoicing: For the issuance of invoices related to services provided.
- Liaison with Professionals: Medical and treatment information may be shared with your GP, health professionals involved in your care, third parties involved in your care and referring medical consultant, but only with your explicit permission.
- Marketing Communications: Periodic emails about Neu Voice Solutions' services, products, events, or information you may find interesting (with your consent).
- Feedback: To contact you for feedback on the services received.
- Service Improvement: To analyse and enhance the services provided by Neu Voice Solutions.

4. Security

Neu Voice Solutions is committed to safeguarding your personal information. Measures in place include:

- **Electronic Data:** Stored securely on a password protected hard drive only used for Neu Voice Solutions. Any documents or programmes containing confidential information are password protected.
- Audio and video recordings: Stored on password protected devices.
- Paper Records: If required, stored in a locked cabinet with controlled access.
- Retention Policy: Patient data is retained for 8 years for adults and 25 years for children, in compliance with legal requirements.



• **Safeguarding:** In the event of a safeguarding concern, where yourself or another person is at risk of harm, we have a legal obligation to share that information with relevant professionals in line with the Safeguarding Children's Act 2004 and the Care Act 2014.

5. Cookies

Neu Voice Solutions' website uses traffic log cookies (e.g., Google Analytics) to analyse web traffic and improve the website. These cookies:

- Identify pages being used to tailor the website to client needs.
- Provide no access to your computer or personal information beyond the data you choose to share.

Control Options:

You can choose to accept or decline cookies. Most browsers automatically accept cookies, but you can modify your settings to decline them if you prefer. Declining cookies may impact your ability to fully use the website.
